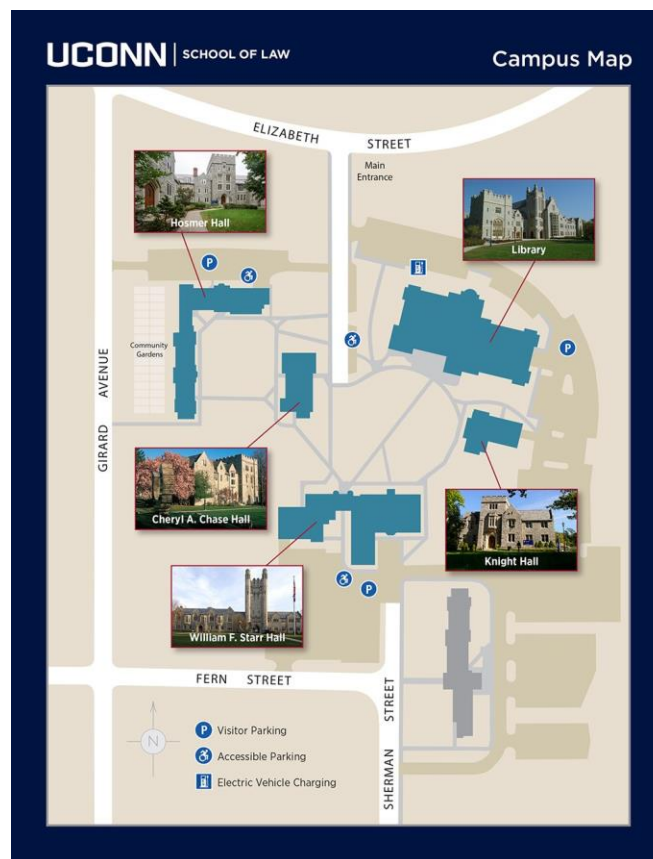
About UConn School of Law's Campus

[UConn's Law School](#) is located on a beautiful, collegiate, gothic campus in a pleasant neighborhood of Hartford, Connecticut's capital city.

UConn Law School is within two hours of New York, Boston, New Haven, Providence, ski mountains, and the seashore. Additionally, UConn students gain access to [U-Pass](#), which allows enrolled UConn students to use CT transit services for free.

Admissions



Application Procedure and Deadlines for UConn Law

Applications are considered during nomination windows. First, partner institutions should nominate exchange students between **September 2nd - October 1st** for Spring enrollment and between **February 24th - April 1st** for Fall and Academic Year enrollment. Once the students have been nominated by the home institution, an email will be sent to the students with the application instructions.

All international student applications should be received by **April 15th** for Fall/AY enrollment or **October 15th** for Spring enrollment. Applications received before these dates will be given priority consideration.

Tuition and Fees for Exchange Students

Exchange students pay tuition and fees to their home institution. Exchange Students are responsible for the costs related to housing/accommodations, travel, visa, health insurance, books, transcript fees, and other miscellaneous expenses during the Exchange Program.

Language Requirements for Exchange Students



Language Requirements

UConn School of Law requires an English language proficiency exam. For the results to be considered valid, the exam *must* be taken within two years of your UConn application.

You may choose from one of the following tests to assess English language proficiency:

TOEFL: If taking the TOEFL exam, students must achieve a minimum score of 90 (internet-based).

IELTS: If taking the IELTS exam, students must achieve a minimum score of 7.0

Cambridge English: Advanced (CAE): The level required is C1 or better.

Pearson Test of English (PTE): The student must score within or above the range of 65 or higher.

Exemptions

The student may be exempt from submitting a TOEFL, IELTS, CAE or PTE if:

- The student is earning a degree from a recognized institution of higher learning at which the primary language of instruction is English.
- The student has earned a proficiency certificate from UCAELI (University of Connecticut American English Language Institute) [or the English Language classes offered at UConn Law with pre-approval of the International Programs department].
- The student's primary language is English. A primary language is defined as a language used to communicate since childhood.

Course Information



Course Selection/Registration

Once admitted to our exchange program, our team will assist with course selection. Students should send course selections to our team at lawexchange@uconn.edu prior to their arrival on campus. Students are able to view course availability for their exchange semester by logging into their Student Administration account.

Students have until the end of the add/drop period to add or drop courses. Following the add/drop deadline, students will need permission from the International Programs Department to drop courses.

Course Restrictions

Students must have the necessary prerequisites described in the course catalogue in order to take a course.

Minimum Course Load

Due to visa regulations, the minimum course load required for international exchange students is 9 credits. The average course load for students is 12 credits. Students must also take enough credits to satisfy requirements from their home university.

Exchange to LL.M. Advanced Standing Program



Transferring from an Exchange Student to LL.M. Degree

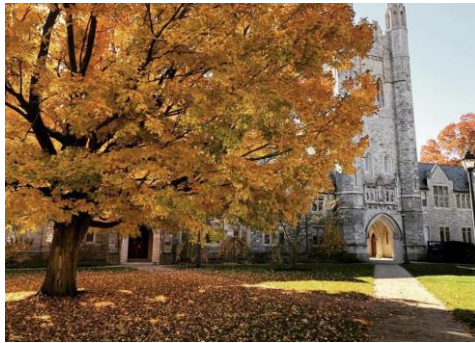
Upon completion of the UConn Law exchange program, exchange students can apply up to 12 credits from their international exchange at UConn Law towards the LL.M. degree 24-credit requirement.

Application to the LL.M. program is subject to the following conditions:

- Exchange students are eligible to apply to the LL.M. program while they are still working on their first law degree
- The exchange student must have applied to the LL.M. program no later than five years after the end of the student's exchange study.
- The Director of Graduate Programs & Admissions shall determine the precise number of transferable credits (student must earn a "B" or above to earn transfer credits).
- A former exchange student who transfers into the LL.M. program will not be eligible to apply for the "LL.M. to J.D. program."

LL.M. Program in U.S. Legal Studies

UConn Law offers a general LL.M. program for lawyers who obtained their first law degree outside the U.S. The program offers certificates of specialization in following areas: corporate and regulatory compliance, energy and environmental regulation, intellectual property, international human rights, tax law, and the foundations of U.S. law.

LL.M. in Energy and Environmental Law Students

The Energy and Environmental LL.M. will help students develop expertise in global energy needs, climate change, renewable energy policy and environmental policy and land use. Students will have access to externships and applied research in numerous areas.

LL.M. in Governance, Risk Management and Compliance

The Governance, Risk Management and Compliance LL.M. offers students an opportunity to study legal and regulatory risk within organizations. Students will gain competence in the law regarding enterprise risk management and governance.

LL.M. in Human Rights and Social Justice

UConn Law's LL.M. in Human Rights and Social Justice offers students the opportunity to integrate the international and domestic dimensions of social justice lawyering. Students can take classes at the law school and at the [Human Rights Institute](#).

LL.M. in Insurance Law

UConn Law's LL.M. in Insurance Law is the top destination for lawyers and students from the U.S. and around the world who seek serious graduate training in insurance and financial services law. The program offers a certificate in financial services regulation.

LL.M. in Intellectual Property and Information Governance

UConn School of Law's LLM in Intellectual Property Law and Information Governance positions graduates to provide legal guidance for the global business environment and prepares you for policy work and understanding how to balance competing private and public demands for innovation in the arts, markets, and new technologies.

Doctor of Laws (S.J.D.)

The S.J.D. Program is intended for individuals who have demonstrated evidence of superior scholarly potential and who are engaged in, or plan to pursue, careers in academia, government service, or the judiciary.

Living in Hartford



The Hartford area contains many riches in cultural, recreational and educational resources. The region also offers many opportunities to see live performances and has a wealth of wonderful restaurants.

Here is a small list of what Hartford has to offer:

Museums

- Wadsworth Atheneum – oldest public art museum in the United States
- Mark Twain House
- Harriet Beecher Stowe House

Theater and music

- The Bushnell – Hartford symphony and theater performances
- Xfinity Theatre – concerts
- PeoplesBank Arena — exhibits, sports events (including UConn Huskies), and concerts
- TheaterWorks – discounted student tickets
- Cinestudio, RealArtWays and Cinépolis Movie Theaters —movie tickets range from \$8 (with student ID) - \$16 (evening)

Sports

- UCONN football, basketball & hockey games and Hartford Wolfpack (hockey) and Hartford Athletic (soccer) games

- UConn Law students are eligible to claim free student tickets to the same athletic games as UConn undergraduate students.
- Elizabeth Park – tennis courts, basketball courts, walking/running paths (10-minute walk from the UConn Law campus)
- Hiking, running, and biking – nearby trails are located in West Hartford reservoir
- Skiing – Three downhill ski areas in CT are within 40 minutes of the law school and cross-country skiing is also available at state parks in the area

UConn Identification Cards & Student Numbers



UConn PeopleSoft ID: Your UConn ID number (often called your PeopleSoft number) is a seven-digit number specifically assigned to you. This ID number is often referenced when discussing course registration and billing.

NetID: Your NetID gives you access to your e-mail, online course management systems (HuskyCT), and other services on campus. You will use PeopleSoft (also referred to as Student Administration System/Student Admin) to access your grades, view your fee bill, etc. You will **NOT** use this system to register for classes.

NetID Instructions:

You should receive your NetID with instructions and activation code in two emails. If you don't receive them, you can go to NetID and click on "Find NetID".

Once you receive your NetID, please go to [NetID > Home \(uconn.edu\)](#) to activate your ID (click on "Activate NetID") and reset your password. Once you activate your NetID password, you will use the same password for your e-mail account (below). You can use this number to access the Student Administration system also known as PeopleSoft. For security reasons, we strongly recommend that you change your password the first time you login.
