Introducción al derecho español (Introduction to Spanish Law)	The course conveys basic knowledge of Spanish law, such as the structure of the judicial system in Spain and its differences with the German system. The structure of the judiciary and its courts will be discussed. In addition, they will learn about the different types of laws, their functions and the approval processes. Consequently, the functioning of the legislative power, the role of the King of Spain and the President within the Spanish legal system will be studied in depth.	2	6		✓
Derechos humanos y derecho penal (Human Rights and Criminal Law)	On the one hand, the course will talk about internationally recognized human rights. Practical cases will be solved by applying different international systems of human rights protection. On the other hand, the criminal system and process in Spain and different Latin American countries will be discussed. At the end of the course, aspects of the subject of human rights will be combined with aspects of the criminal process, looking for common points and differences.	2	6	<b>✓</b>	
<b>Derecho constitucional</b> (Spanish Constitutional Law)	The course focuses on the fundamental rights contained in the Spanish Constitution. This includes their content but also the respective legal guarantees. The focus of a second analysis is the Statutes of the Autonomous Communities. The Ombudsman and his functions within the constitutional framework will also be discussed.	2	6	<b>√</b>	
Derecho civil I (Spanish Civil Law I)	An important part of the course is the knowledge of basic civil law institutions such as legal persons, declaration of will and representation. Subsequently, legal capacity, ability to act and the legal meaning of minority will be studied. Part of the course is also the duties of the spouses, the different matrimonial regimes and various related aspects. Finally, the different characteristics and types of organizations of legal persons will be discussed.	2	6	<b>✓</b>	
Derecho civil II (Spanish Civil Law II)	This course will study the basis of the different obligations and contracts, as well as the consequences of compliance and non-compliance. Part of the course will also be non-contractual responsibilities, their functions, their meaning in the process and some procedural law. Within the working method, there is also the application of what has been learned to concrete cases.	2	6		<b>√</b>
